#### Oil Tank Lifetime Protection Plan 9/1/22

Haly Home Comfort [hereinafter referred to as "Haly"] Agrees to provide services as outlined herein. This Agreement covers specified equipment at the property so noted on the customer account and becomes valid on the date indicated on the invoice. The price & coverage as outlined in this Agreement is subject to change at the anniversary date of the Agreement. This Agreement supersedes all previous Tank Protection Plan Agreements.

1. This Agreement extends only to replacement or repair as Haly deems necessary and proper, and does not extend to the cost of the removal or replacement of any part of the building necessitated by the oil tank repair. It is the responsibility of the homeowner to maintain compliance with the local code and jurisdictional requirements. This Agreement covers the maintenance issues of the oil line and vent/fill pipe. This agreement does not include repairs or replacements necessary for code compliance upgrades.
2. This Agreement does not apply to leakage or spillage from the heating oil tank or any part of the heating system. In no event will Haly be liable for incidental or consequential damages relating to or arising from any leakage, spillage, or other escape of heating oil from the tank or any part of the heating system for any reason whatsoever, including frozen fuel lines, acts of nature or any environmental damage that arises out of leaks or spills.
3. This Agreement is not available for tanks having a capacity greater than 330 gallons or for any underground tank. This plan covers 1 qualified tank. Additional plans are required if additional tanks are in service.
4. This agreement is a monthly contract and may be canceled at any time by either party. Payment for this Plan may be made monthly, as part of the customer's monthly budget plan, or paid for 12 months at a time. If the 12-month payment option is chosen, payment must be received within thirty [30] days of the billing date or Haly may terminate this Plan at Haly's option. In addition, this contract will automatically renew every month.
5. Coverage under this agreement will take effect 90 days after enrollment in the Oil Tank Lifetime Protection Plan. No refund in part or whole will be given at any time. This Agreement does not cover repair due to or as a result of accounts held for non-payment. Your account must be up to date and in good standing with payments to receive replacement or repair.
6. The customer must make provisions for Haly to access, and if necessary, remove and replace the tank, without causing damage to the residence. If full access is not available for tank removal and replacement, the customer is responsible for providing access.
